School Clothing Assistance

The West Virginia Department of Human Services (DoHS), Bureau for Family Assistance (BFA), began accepting school clothing allowance applications on July 1, 2024, for eligible children enrolled in West Virginia schools.

Each eligible student will receive a \$200 benefit that may be used toward the purchase of appropriate school clothing or piece goods for families who sew clothing for their children.

School clothing allowance program recipients will receive an electronic benefit transfer (EBT) card instead of the traditional paper voucher. This system change allows for both online transactions and increased choice of vendors when purchasing school clothing or piece goods. The EBT card will operate like a debit card and can be used at any retailer that accepts EBT cash transactions. Parents or guardians of children in foster care will receive the school clothing allowance benefit as a check.

Families may apply online at <u>wvpath.wv.gov</u>. To request a paper application via mail, families may contact their local DoHS county office or the Office of Constituent Services' Customer Service Center at 1-877-716-1212. Applications must be received by July 31, 2024.

The U.S. Department of Education is at the forefront of providing new resources to support students with disabilities.

The U.S. Department of Education's Office for Civil Rights (OCR) has announced three new resources that address the civil rights of students with disabilities, including sickle cell disease, epilepsy, and cancer. They educate students with disabilities, their parents and caregivers, and professionals and schools about their legal rights under Section 504 of the Rehabilitation Act of 1973, what to do to remedy past discrimination, and more.
